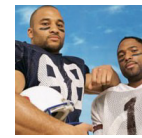

There are several benefits to you as a donor. We have multiple ways to give/pledge. You could receive income tax deductions, potential estate tax deductions, and potential capital gains tax deductions. You will receive recognition for your gift, your pledges may be leveraged and you will be helping be a vital part of our mission. There are also several benefits to A CALL TO MEN, including: expanding the funds available to enhance our programs, and allowing us to further our outreach opportunities and cultivate change.

Talent can be an amazing gift when shown to others, or as a role model. Thank you for helping us highlight your special abilities.

Treasures are the life-blood of any non-profit. Financially supporting our mission, goals, and objectives with your contributions assures our advocacy will reach many in need.

WILLS & BEQUESTS

Your bequest can be simply done through a bequest in your will or trust. It may be cash or other property. A contingent bequest can be made if other beneficiaries do not survive. Or a gift of a portion or a percentage of an estate can be made. Your legacy can continue long after you are gone.

INCOME BYPASS TRUST

Money or other assets are set aside to provide a lifetime income for as many as two individuals. A charitable income tax deduction is created, capital gains taxes are avoided if funded with capital gains assets. This option allows you to increase your income during your lifetime and after payments end, the remaining assets can be distributed to your family.

LIFE INSURANCE

For a small sum, you can leverage a potentially large gift through life insurance. The premiums you pay are deductible. And you can make a large gift on the "installment plan" <in as little as 7 years>. This option is also self completing upon your death with the proceeds payable to A CALL TO MEN.

GIFTS OF REAL ESTATE

Appreciated real estate may be an ideal gift to give to A CALL TO MEN because of the flexibility in design, and all appreciation escapes federal income tax and capital gains tax. This option is tax deductible at full fair market value, subject to some limitations. It can provide lifetime income to the donor and may be combined with an Income Bypass Trust.

GIFTS OF APPRECIATED SECURITIES

Stocks, bonds and mutual funds that have increased in value over the years, and held for at least one year, may allow you to avoid capital gains tax. It can also provide an income tax deduction. And, the management of assets may be repositioned into a higher paying income stream to A CALL TO MEN, you or both!
